This is a conditional burn permit in accordance with the City of Duncan Ordinance 1638 (which covers the penalties of open burning without a permit) within the jurisdiction of the City of Duncan. The applicant agrees to the following conditions.

1. Before you begin you must first contact the City of Duncan Communication Center and have them notify the Assistant Chief on duty each day.
2. Burning will not be allowed when the wind is over 10 m.p.h.
3. There must be twenty feet (20') of protective clearance area around the burn site.
4. Burning time is from one (1) hour after sunrise to three (3) hours before sunset and additional fuel may not be intentionally added to the fire at times outside the limits stated above.
5. Fire extinguishing equipment must be on the premises at each burn site, during burning, i.e. extinguisher, water hose, etc. Any open burning shall be constantly attended until the fire is extinguished.
6. The burning permit will be valid for fourteen (14) calendar days beginning the day it was issued.
7. Size of the burn site fuel shall not be larger than ten feet, by ten feet, by ten feet (10' wide x 10' in length x 10' high from the ground surface).
8. The location of burning must be at least five hundred feet (500') from all residences, any business structure, and other burn sites other than those located on the property on which the burning is conducted.
9. Any petroleum based product or similar materials which produce unreasonable amounts of air contaminants may not be burned. If the burning is offensive or a nuisance due to smoke or odor emissions the permit holder must extinguish immediately.
10. The Fire Chief, or designated representative, shall inspect the site of the proposed burning in the presence of the applicant, and may make such requirements as necessary and appropriate to prevent the spread of any permitted burning, including, but not limited to, provision of fire breaks as condition of permit approval. In the event that such conditions are provided, verification of compliance shall be a condition of approval to proceed as requires below.
11. The holder of the burn permit must provide to the city with, (at the time the permit is issued) a ten thousand dollar (\$10,000.00) permit bond or verification of liability insurance in an amount of not less than one hundred thousand dollars (\$100,000.00), with said bond or insurance being subject to lien for any and all damages and/or injuries resulting from said open burning.

Applicant has read and understands the attached rules and regulations and hereby agrees to accept full responsibility for any damage or loss to property or personal injuries arising out of any act or omission on the part of the applicant or his agents; also per City Code #10-304 et al.
